



Terms & Conditions Governing the OCBC 10% off AutoWise Insurance Comprehensive (Any workshop or Authorised workshop) Plan Promotion (the “Promotion”)

1. The Promotion is jointly organised by Oversea-Chinese Banking Corporation Limited (“OCBC Bank”) and Great Eastern General Insurance Limited (“GE Insurance” and, collectively, the “Organisers”).

Eligibility and Promotion Period

2. You will qualify for the Promotion (“Eligible Customer”) if you have successfully signed up for an AutoWise Comprehensive (Any workshop or Authorised workshop) Plan (“Autowise Plan”) via OCBC website from 1 January 2022 to 30 June 2022 (“Promotion Period”).

Promotion Mechanics

3. Eligible Customers will be entitled to receive a 10% off their premium for the AutoWise Plan. AutoWise Plan is a car insurance plan that covers loss or damage to your vehicle due to accidents and is an insurance policy underwritten by GE Insurance.
4. Great Eastern will send the Eligible Customers a hard copy with full details of the AutoWise Plan Insurance policy to the applicant’s mailing address upon successful sign-up of the AutoWise Plan.
5. The AutoWise Plan is a 1-year period coverage from the date the customer select and is approved to be covered.
6. If any Eligible Customer is subsequently discovered to be ineligible to participate in the Promotion, The Organisers reserves the right to (i) forfeit or withdraw the Promotion at any time; or (ii) (where the Promotion has been redeemed) request the relevant customer to repay to or compensate the Organisers the value of the Promotion at any time, and the Organisers shall have the right to debit the value of the Promotion plus any goods and services tax or such other amount as it deems fit from the account(s) of the customer. No person shall be entitled to any payment or compensation from the Organisers should any Promotion be forfeited or withdrawn, or if a customer is asked to repay to or compensate the Organisers the value of the Promotion for whatsoever reasons.

General

7. The eligibility of any Eligible Customer to participate in this Promotion shall be determined at the absolute discretion of the Organisers.

Notwithstanding anything herein, OCBC shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.
10. The Organisers’ decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by the Organisers. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.



11. The Organisers shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.
12. These terms and conditions shall be governed by the laws of Singapore and each participant in the Promotion irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore. Other than the Organisers, a person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
