

## Terms & Conditions Governing the OCBC Explorer Single Trip 45% off (the “Promotion”)

### 1. Promotion Period

You will qualify for the Promotion (an “**Eligible Customer**”) if you have performed an **eligible transaction** during the promotion period from 15 August 2022 to 31 December 2022 (both dates inclusive) (the “**Promotion Period**”).

### 2. Eligible Transaction

**2.1.** An Eligible Transaction is defined as any flight, hotel and/or car rental booking made on the Travel with OCBC travel portal (travelwithocbc.com) (the “**Travel Portal**”) during the Promotion Period.

### 3. Promotion Mechanics

- 3.1.** Subject to the fulfilment of all the conditions specified in these terms and conditions to the absolute satisfaction of the Organisers, an Eligible Customer who performs an Eligible Transaction will be entitled to a 45% discount off the premium payable for Essential and Ultimate Single Trip Plans under the Great Eastern Explorer travel insurance policy (“**Discounted Premium**”), if the Eligible Customer enters the promotion code (sent to Eligible Customer’s email) at the Great Eastern Explorer online checkout page.
- 3.2.** The promotion code is not exchangeable for cash, gift vouchers, gift cards, loyalty redemption programme points, and/or other goods and services.
- 3.3.** There is no limit to the number of times that an Eligible Customer who performs an Eligible Transaction can enjoy the Discounts during the Promotion Period.
- 3.4.** If any Eligible Customer is subsequently discovered to be ineligible to participate in the Promotion, The Organisers reserves the right to (i) forfeit or withdraw the Promotion at any time; or (ii) (where the Promotion has been redeemed) request the relevant customer to repay to or compensate the Organisers the value of the Promotion at any time, and the Organisers shall have the right to debit the value of the Promotion plus any goods and services tax or such other amount as it deems fit from the account(s) of the customer. No person shall be entitled to any payment or compensation from the Organisers should any Promotion be forfeited or withdrawn, or if a customer is asked to repay to or compensate the Organisers the value of the Promotion for whatsoever reasons.

### 4. General

- 4.1.** The eligibility of any Eligible Customer to participate in this Promotion shall be determined at the absolute discretion of the Organisers.
- 5.** The Organisers reserves the right at its absolute discretion to terminate the Promotion or vary, delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any customer and the dates of the Promotion.

6. OCBC shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Promotion, or any product and/or service relating to the Promotion.

Notwithstanding anything herein, OCBC shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.

7. The Organisers' decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by the Organisers.

In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.

8. The Organisers shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.
9. These terms and conditions shall be governed by the laws of Singapore and each participant in the Promotion irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore.

Other than the Organisers, a person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
