

## Terms & Conditions Governing the GREAT TravelCare National Day Flash Deal 2026 Campaign (the “Promotion”)

### Eligibility and Promotion Period

1. The Promotion is organised by Great Eastern General Insurance Limited (“**GEG**”). GREAT TravelCare policy is underwritten by GEG and distributed by Oversea Chinese Banking Corporation Limited (“**OCBC Bank**”).
2. You will qualify for the Promotion (“**Eligible Customer**”) if you have successfully signed up for a GREAT TravelCare new policy from 31 July 2026 to 10 August 2026, both dates inclusive (“**Promotion Period**”).

5. This Promotion cannot be used in conjunction with other discount or promotions, unless otherwise specified.
6. This Promotion is only applicable for base plans only. The additional premium for pre-existing condition add-on benefit is not eligible for the discount.

  - a) The policy is not cancelled subsequently.
  - b) The policy purchase is made via online sales platform or via telemarketing
