Terms and Conditions for OCBC Eco-Care Car Loan Promotion

- 2. Applicants who have (i) successfully applied for an OCBC Eco-Care Car Loan to finance the purchase of a fully electric vehicle ("EV") and (ii) whose loan is approved and disbursed during the Promotion Period are eligible to participate in this Promotion ("Eligible Applicants").
- 3. Audi e-tron, Jaguar I-PACE or Nissan Leaf buyers who reside in landed properties will receive a free Charge+ charging station provided by Premium Automobiles, Wearnes Automotive or Tan Chong Motors respectively, with the charging station installed by Charge+ Pte Ltd at the cost of Premium Automobiles, Wearnes Automotive or Tan Chong Motors respectively ("Additional Benefits").
- 6. The eligibility of an Eligible Applicant to receive the Free Charging shall be determined at the absolute discretion of OCBC. If Charge+ performs services for an applicant in relation to the Charge+ charging station, and such applicant (i) is not an Eligible Applicant, (ii) is subsequently discovered to not be an Eligible Applicant or (iii) is subsequently discovered to be ineligible to participate in the Promotion, OCBC may request such applicant to repay to or compensate OCBC the value of the services performed by Charge+ plus any goods and services tax at any time. OCBC shall have the right to debit the value of the services performed by Charge+ plus any goods and services tax from the account(s) of that applicant. Free Charging, Charge+ Benefits and/or Additional Benefits or deficiency in the Free Charging, Charge+ Benefits and/or Additional Benefits, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Free Charging, Charge+ Benefits and/or the Additional Benefits and/or the use or enjoyment thereof, by any person. OCBC shall also not be responsible for honouring the Free Charging, Charge+ Benefits and/or Additional Benefits. The Free Charging, Charge+ Benefits and/or the Additional Benefits are strictly not exchangeable for cash. OCBC reserves the right to substitute or replace the Free Charging, Charge+ Benefits and/or the Additional Benefits with any item of similar value at its sole discretion without notice to any person.

- 8. OCBC reserves the right at its absolute discretion to terminate the Promotion or vary, delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any person and the dates of the Promotion.
