

Terms and Conditions Governing OCBC MyOwn Account Selected Sunday Banking Branch Activities Promotion January 2025

The OCBC MyOwn Account Selected Sunday Banking Branch Activities Promotion January 2025 (the "**Promotion**") commences from 28 December 2024 and ends on 14 January 2025 at OCBC Jurong Point, commences from 4 January 2025 and ends on 15 January 2025 at OCBC Tiong Bahru Plaza, commences from 17 January 2025 to 31 January 2025 at OCBC Hougang Mall, and commences from 18 January 2025 to 31 January 2025 at OCBC Ang Mo Kio Central (or any such date(s) as may be determined and notified by OCBC Bank in its sole discretion) ("**Promotion Period**") or while stocks last.

1. Eligibility

1.1. The Promotion is open to customers who visit the selected OCBC Sunday Banking branches during the respective Promotion Period. ("Eligible Customer").

2. Promotion Mechanics
