

**Terms and Conditions Governing OCBC SeniorCare Branch Activities Financial Needs Analysis
(FNA) Promotion October 2026
(Exclusive to OCBC Tampines Branch only)**

The OCBC SeniorCare Branch Activities Financial Needs Analysis (FNA) Promotion October 2026 (the “**Promotion**”) takes place on 4 October 2026 from 11:00 to 15:00 (the “**Promotion Period**”) or such other periods(s) as may be determined and notified by Oversea-Chinese Banking Corporation Limited (“**OCBC Bank**”) at its absolute discretion or while stocks last.

1. Eligibility

- 1.1 The Promotion is open to customers who visit the OCBC Tampines Branch during the Promotion Period. (“**Eligible Customer**”).

2. Promotion Mechanics

- 2.1 An Eligible Customer who successfully completes a Financial Needs Analysis (“**FNA**”) with a Personal Wealth Manager at OCBC Tampines Branch during the Promotion Period (“**Qualifying Customer**”) shall be entitled to receive one (1) S\$20 voucher (the “**Voucher**”), while stocks last and subject to OCBC Bank's verification.
- 2.2 Each Qualifying Customer is entitled to a maximum of one (1) Voucher during the Promotion Period, regardless of the number of Financial Needs Analysis (FNAs) completed. The Voucher is strictly non-transferable and non-exchangeable for cash, credit, or any other item.
- 2.3 OCBC reserves the right to substitute or replace the Voucher or part thereof with an item of similar value at its sole discretion without notice to any person.
