

Terms & Conditions Governing Sure-win prizes with OCBC 365 Credit Card & OCBC Rewards Card (the "Activity") at 4 Watsons Stores

Activity Period

1. The Activity shall commence on 19 April 2024 till 21 April 2024, from 12pm to 8pm or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion ("Activity Period").
