

## **Terms & Conditions Governing the OCBC Cardmember Privileges at Disney Garden of Wonder (the "Promotion")**

### **1) Promotion Period**

- (a) The promotion period shall run from 1 December 2024 to 30 June 2025 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Period").

### **2) Eligibility**

- (a) You will qualify for the Promotion ("Eligible Cardmember") if:
- you hold an Eligible Card;

### **3) Definitions**

- (a) "Eligible Card" means any Visa, MasterCard or China UnionPay credit/debit card issued by OCBC Group in Singapore, Malaysia, Indonesia, Hong Kong or Macau (whether or not it also bears the name and/or mark of any other person or entities).

### **4) Promotion Mechanics**

#### **(a) OCBC Disney Garden of Wonder Bundle**

Eligible Cardmembers who make a purchase of Garden of Wonder ticket(s) will be entitled to the OCBC Disney Garden of Wonder Bundle ("Bundle"), as defined below, subject to the following terms and conditions.

Bundle includes:

- Admission ticket to Disney Garden of Wonder at Floral Fantasy for one pax
- Shuttle Service
- S\$5 retail voucher (minimum retail spend of S\$15)

Terms and conditions:

- Valid for purchases of Garden of Wonder tickets made during the Promotion Period.
- Payment must be made with an Eligible Card.
- Admission rates for Garden of Wonder are subject to changes.
- This Promotion is valid only for direct purchases of Garden of Wonder tickets at on-site ticketing counters located at Gardens by the Bay.
- For avoidance of doubt, the maximum number of Bundles each Eligible Cardmember can obtain per transaction is 8.
- Singapore Residents who purchase Garden of Wonder ticket(s) at rates for Singapore Residents may be required to present proof of residency for purchase or admission. Singapore Resident refers to Singapore Citizens, Permanent Residents, as well as those living in Singapore, including Employment Pass, Work Permit and Dependent Pass holders.
- Payment must be made with a valid Eligible Card.
- Not valid in conjunction with other discounts, membership privileges, promotions or vouchers.
- Bundle includes 2-way rides for one (1) pax on the Shuttle Service, only for: Bayfront Plaza (Exit B from Bayfront MRT) ↔ Active Garden ↔ Flower Dome.

- Payment must be made on-site with an OCBC credit or debit card.
- The mystery gift is applicable for redemption with any purchase at the Floral Fantasy Gift Shop on a first-come-first-served basis, while stocks last.
- The mystery gift will be given at random, and no exchanges of the mystery gift are allowed. OCBC Bank's decision on all matters in relation to the mystery gift will be final and binding on all participants of the Promotion. No correspondence or appeal shall be entertained by OCBC Bank.
