Terms and Conditions Governing the VOYAGE Year-End Top Spenders Promotion

Promotion Period

 The promotion period shall run from 1 October till 15 November 2021 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Period").

Eligibility

2. You will qualify for the Promotion ("Eligible Cardmember") if:

- i. you are currently residing in Singapore (as evidenced by your mailing address registered with OCBC Bank);
- ii. you are a principal cardholder of a VOYAGE Card (as defined below); and
- iii. your VOYAGE card account is active and in good standing with OCBC Bank from the start of the Promotion Period until the point of fulfilment;
- iv. you meet the qualification requirements of the relevant offer as follows:
 - (a) For Offer 1, you are among the top 350 Eligible Cardmembers with the highest amount in Qualifying Spend 1 made within the Promotion Period.
 - (b) For Offer 2, you (1) have made at least \$\$5,000 of Qualifying Spend 2 (the "Minimum Spend Requirement"); and (2) are among the top 3 with the highest amount in Qualifying Spend 2 made within the Promotion Period.

Definitions

- 3. VOYAGE Card refers to any of the following cards:
 - i. Bank of Singapore VOYAGE;
 - ii. OCBC Premier Private Client VOYAGE;
 - iii. OCBC Premier VOYAGE; and
 - iv. OCBC VOYAGE Card.
- **4. "Qualifying Spend"** refers to either Qualifying Spend 1 or Qualifying Spend 2, as the context requires.

5. "Qualifying Spend 1" for Offer 1:

- refers to any retail transaction (including face-to-face or online purchases) as defined in clause 1 of the Terms and Conditions Governing The VOYAGE Credit Card Programme (accessible <u>here</u>); and
- ii. excludes the transactions specified as "excluded transactions" in Clause 1.4 of the Terms and Conditions Governing The VOYAGE Credit Card Programme; and
- iii. will be determined by its transaction date based on Singapore Timing (UTC+08:00) and must be posted for the spend to be qualified. For avoidance of doubt, the date on which the transaction is submitted or posted may differ from the actual date the transaction was made and OCBC Bank bears no liability for any late submission or transaction posting of any purchase by any merchant that might affect the Promotion.

6. "Qualifying Spend 2" for Offer 2:

i. Refers to transactions made at Luisaviaramo site (accessible <u>here</u>). To qualify, a minimum spend of \$\$5,000 must be made.

- 7. Refunded or cancelled transactions will be deducted from the relevant billed amount taken into consideration for the computation of Qualifying Spend.
- 8. The Qualifying Spend can be aggregated between Principal and Supplementary Cardmembers of the Card and is only valid for transactions posted.
- 9. Eligible Cardmembers who meet the requirements for either Offer 1 or Offer 2 shall be entitled to receive a reward (the "Gift") as set out below, subject to these terms and conditions. - 15. Each Eligible Cardmember is entitled to a maximum of one (1) Gift in Offer 1 and Offer 2 upon meeting the terms and conditions of this Promotion, in accordance with the order established in Clause 10 and 12 above.
- 16. OCBC Bank reserves the right in its sole and absolute discretion to determine whether a transaction qualifies as a Qualifying Spend under the Promotion. If OCBC Bank in its sole and absolute discretion decides that any transaction from which the Qualifying Spend is computed is not to be considered a valid transaction, the Gift will not be awarded.
- 17. OCBC Bank reserves the right to claw-back and deduct from the Eligible Cardmember's VOYAGE Card account (the "Account") the equivalent value of the Gift if the Eligible Cardmember closes his/her Account during, or within six (6) months from the end of, the Promotion Period. Further, if any Eligible Cardmember is subsequently discovered to be ineligible to participate in the Promotion or to receive the Gift (which eligibility shall be determined at the discretion of OCBC Bank), OCBC Bank reserves the right to (i) forfeit or withdraw the Gift at any time; or (ii) (where the Gift has been redeemed) claw-back the Gift or request the relevant customer to repay to or compensate OCBC Bank the value of the Gift at any time, and OCBC Bank shall have the right to debit the value of the Gift plus any goods and services tax or such other amount as it deems fit from the account(s) of the customer. Gift
