

**Terms & Conditions Governing the OCBC Apply New Credit Card Promotion (Online Exclusive)  
Promotion 13 October 2023 to 30 November 2023(the “Promotion”)**

**Promotion Period**

1. The promotion period shall run from 13 October 2023 to 30 November 2023 (both dates inclusive) or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited (“OCBC Bank”) at its absolute discretion. (the “Promotion Period”).

**Eligibility**

2. You will qualify for the Promotion (“Eligible Cardmember”) if:
  - i. you are an existing principal OCBC Credit Cardmember; and
  - ii. you have received a communication inviting you to participate in this promotion; and
  - iii. you have applied for an OCBC INFINITY Cashback Card (“Eligible Card”) as a principal cardmember via the link stipulated in the communication during the Promotion Period and whose Card application has been approved by 11:59 PM on 31 December 2023; and
  - iv. your Card account is active and in good standing with OCBC Bank from the start of the Promotion Period until the point of fulfilment;

**Definitions**

3. “Qualifying Spend”:
  - i. refers to any retail transaction (including face to face or online purchases);
  - ii. does not include payments or transactions relating to annual card fees, insurance premiums, Cash-On-Instalment IPP, extended payment plan, income tax payment, bill payments made via Internet Banking, bill payments made via AXS, interest, late payment charges, goods and services taxes, cash advances, balance transfers, bus/MRT transactions, Transit top-up and other bank fees and charges;
  - iii. does not include payments made to or transactions performed at merchants that fall into the exclusion categories/excluded organisations as set out by OCBC Bank for the following products:
    - **OCBC INFINITY Cashback Card**

  - iv. will be determined by its transaction date based on Singapore Timing (UTC+08:00). For avoidance of doubt, the date on which the transaction is submitted or posted may differ from the actual date the transaction was made and OCBC Bank bears no liability for any late submission or transaction posting of any purchase by any merchant that might affect the Promotion;
  - v. any refunded or cancelled transactions will be removed from the computation of Qualifying Spend for the purpose of determining such Eligible Cardmember’s entitlement to the Offer.

**Promotion Mechanics**

4. Eligible Cardmembers who meet the conditions herein will receive one cashback from Application Offer and one cashback from Spend Offer (“Offer”) (as set out below), subject to these terms and conditions:
  - i. Eligible Cardmembers will earn S\$50 cashback for making one Qualifying Spend of any amount on the Eligible Card from the day of the Eligible Card approval till 31 December 2023 (“Qualifying Spend Period”) (“Application Offer”);
  - ii. Eligible Cardmembers will earn bonus 0.4% cashback for the first S\$5,000 Qualifying Spend charged to the Eligible Card from the day of the Eligible Card approval till 31 December 2023

("Qualifying Spend Period") ("Spend Offer"). This Cashback is on top of the 1.6% cashback that Cardmembers earn as part of the card benefits stated in the Terms and Conditions Governing OCBC INFINITY Cashback Card Programme.

For the avoidance of doubt, after the first S\$5,000 Qualifying Spends, any additional spends on the Eligible Card within the Qualifying Spend Period will not earn bonus 0.4% cashback.

5. Only 1 Eligible Card can be registered by the Eligible Cardmember for the Promotion.
6. For principal cardmembers with supplementary Cards, Qualifying Spend charged to the supplementary Card will be aggregated under the Qualifying Spend for the principal Card.
7. OCBC Bank reserves the right in its sole and absolute discretion to determine whether a transaction qualifies as a Qualifying Spend under the Promotion. If OCBC Bank in its sole and absolute discretion decides that any transaction is not to be considered a valid transaction, the Cashback will not be awarded.
8. Eligible Cardmember will receive both cashbacks by the date falling two (2) months after the Eligible Cardmember's Qualifying Spend Period.
9. The Promotion shall not apply in conjunction with any other privileges or promotions.
10. OCBC Bank reserves the right and at any time at its absolute discretion and without giving any reason or notice to withdraw, clawback, cancel and/or invalidate any Offer awarded to any customer without liability. A customer will not be entitled to any payment or compensation whatsoever in respect of such withdrawal, clawback, cancellation or invalidation.
11. OCBC Bank reserves the right to claw-back and deduct from any of the Eligible Cardmember's accounts with OCBC Bank the equivalent value of the Cashback if the Eligible Cardmember closes his/her Eligible Card account during, or within six (6) months from the end of, the Promotion Period. If any Eligible Cardmember is subsequently discovered to be ineligible to participate in the Promotion or to receive the Cashback, OCBC Bank reserves the right to (i) withdraw the Cashback at any time; or (ii) claw-back the Cashback or request the relevant customer to repay to or compensate OCBC Bank the value of the Cashback at any time, and OCBC Bank shall have the right to debit the value of the Cashback or such other amount as it deems fit from the account(s) of the customer. No person shall be entitled to any payment or compensation from OCBC Bank should any Cashback be withdrawn, if any Cashback is reclaimed by OCBC Bank, or if a customer is asked to repay to or compensate OCBC Bank the value of the Cashback for whatsoever reasons.

## **General**

12. The eligibility of any Eligible Cardmember to participate in this Promotion and/or receive any Cashback shall be determined at the absolute discretion of OCBC Bank.
13. OCBC Bank reserves the right at its absolute discretion to terminate the Promotion or vary, delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any customer and the dates of the Promotion.
14. OCBC Bank shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Promotion, or any product and/or service relating to the Promotion. Notwithstanding anything herein, OCBC Bank shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.
15. OCBC Bank's decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.
16. OCBC Bank shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.
17. These terms and conditions shall be governed by the laws of Singapore and each participant in the Promotion irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these terms and conditions.
