

# TERMS AND CONDITIONS GOVERNING THE VISA INFINITE FOREIGN CURRENCY SPEND PROMOTION (the "Promotion")

#### **Promotion Period**

 The promotion period shall run from 1 December 2023 Singapore Time (SGT) 00:00 to 31 December 2023 SGT 23:59 (both dates inclusive), or such other periods(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Period").

## **Eligibility**

- 2. You will qualify for the Promotion ("Eligible Cardmember") if:
  - a. you are an existing main cardholder (the "Eligible Card");
  - b. you have received a SMS from OCBC bank inviting you to participate in the Promotion (please note that the invitation to participate in the Promotion is not transferrable);
  - c. you have successfully registered your interest in the Promotion by sending an SMS to 72377 with: FX10<space>Date of birth in DDMMYYYY format (e.g. FX10 010188). You must use the mobile number that is in our records;
  - d. you have spent a minimum of S\$5,000 equivalent in Qualifying Spend (as defined below) and are among the first 200 Eligible Cardmembers within the Promotion Period; and
  - e. your Eligible Card account is active and in good standing with OCBC Bank from the start of the Promotion Period until 6 months after the end of the Promotion Period.

### **Definitions**

- 3. "Eligible Cards" means any of the following OCBC Cards:
  - a. OCBC VOYAGE Card
  - b. OCBC Premier Visa Infinite Card
- 4. Refers to any foreign currency transaction (including face-to-face or online purchases);
- 5. Does not include payments or transactions relating to annual card fees, Cash-On-Instalment, Instalment Payment Plan, PayLite, extended payment plan, interest, late payment charges, cash advances, balance transfers, tax payments, bill payments made via Internet Banking, AXS or SAM network, transactions made at TransitLink General Ticketing Machines and other fees and charges.;
- 6. Does not include payments or transactions performed at merchants that fall into the exclusion categories/excluded organisations as set out below:

- a. Transactions under Transportation and Tolls MCC 4111/4121/4131.
- b. Funds to prepaid accounts and merchants who are categorised as "payment service providers".



- c. The exclusions are not exhaustive and may be subject to changes from time to time. OCBC Bank has the absolute discretion to determine whether any prepaid account or merchant is considered a "payment service provider".
- d. Transactions made with any "professional services provider" which includes and not limited to GOOGLE Ads, Facebook Ads, Amazon Web Services, MEDIA TRAFFIC AGENCY INC. OCBC Bank has the absolute discretion to determine which provider is considered a "professional services provider".
- e. For the avoidance of doubt, MCCs are not assigned by OCBC Bank. A merchant's registered MCC may not always correspond with its nature of business, and OCBC Bank shall not be liable in any way whatsoever to any Cardmember relating to the categorisation of a merchant's MCC; and will be determined by its transaction date based on Singapore Timing (UTC+08:00).
- f. For avoidance of doubt, the date on which the transaction is submitted or posted may differ from the actual date the transaction was made and OCBC Bank bears no liability for any late submission or transaction posting of any purchase by any merchant that might affect the Promotion.

#### **Promotion Mechanics**

- 7. 25,000 VOYAGE Miles or 132,000 OCBC\$ will be awarded with a minimum spend of \$\$5,000 equivalent in foreign currency.
- 8. For avoidance of doubt, the Bonus VOYAGE Miles or OCBC\$ will be awarded for up to S\$5,000 spent in total on an Eligible Cardmember's foreign currency. Amounts from both types of transactions shall be combined and calculated cumulatively (Refer to the breakdown below).
- The maximum rewards an on an Eligible Cardmember can earn from this campaign is 25,000 VOYAGE Miles or 132,000 OCBC\$

- 13. OCBC Bank shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Promotion, or any product and/or service relating to the Promotion.

  Notwithstanding anything herein, OCBC Bank shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury,

OCBC Bank disclosing their Personal Data to OCBC Bank's third-party vendors and agencies for the same Purposes; and c. the collection, use and disclosure of their Personal Data for other applicable purposes in accordance with OCBC's Data Protection Policy (accessible at: https://www.ocbc.com/personal-banking/policies).
- 17. These terms and conditions shall be governed by the laws of Singapore and each participant in the Promotion irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these terms and conditions.
