

Terms and Conditions Governing the OCBC PartnerCare Insurance Promotion

("The Promotion")

1. The Promotion

- 1.1 The Promotion is jointly organised by Great Eastern General Insurance Limited ("GEG") and Oversea-Chinese Banking Corporation Limited ("OCBC Bank") (collectively, the "Organisers"). Participating policy is underwritten by GEG and distributed by OCBC.
- 1.2 The promotion period shall run from 1 July to 30 September 2025 (both dates inclusive), or such other period(s) (the "Promotion Period") as may be determined by GEG in its absolute discretion.

2. Eligibility

To be eligible for this Promotion:

- a) You must purchase a new participating insurance policy ("**Policy**") during the Promotion Period.
- b) Your application and insurance premium payment must be accepted by GEG during the Promotion Period.

Notwithstanding anything herein, GEG shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage, or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.
