

## Terms and Conditions Governing the My GREAT PA Plan Launch Promotion (the “Promotion”)

### 1. Promotion Period

1.1 The promotion period shall be from 30 April 2025 to 30 June 2025 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited (“OCBC Bank”) in its absolute discretion (the “Promotion Period”).

### 2. Eligibility

2.1 You will qualify for the Promotion (each, an “Eligible Customer”) if you are the **first 1,000 customers** who fulfil the criteria below:

- a. You purchased a My GREAT PA Plan (“Policy”) within the Promotion Period and incepted by 31 July 2025;
- b. The Policy remains under the “Inforced” status for **at least 3 months** after the Policy is incepted; and
- c. You have an OCBC Current / Savings Account **denominated in Singapore Dollars** that is active and in good standing at time of receiving the Reward (defined below).

### 3. Promotion Mechanics

3.1 During the Promotion Period, Customers who fulfils the criteria stated in clause 2.1 will be eligible to receive a S\$35 cash reward (“Reward”).

#### To illustrate:

- a. A customer who applies for the Policy on 30 April 2025, has the policy **incepted on 1 May 2025**, with the Policy remaining under the “Inforced” status **up till 1 August 2025** will be deemed an Eligible Customer
- b. A customer who applies for the Policy on 30 April 2025, with the policy being **incepted on 1 May 2025**, but chooses to **discontinue the Policy from 30 July 2025**, will not be deemed an Eligible Customer

3.2 The Reward will be credited accordingly into the Eligible Customers’ OCBC account that was used to make payment for the policy, or any other OCBC Singapore Dollar Current/Savings Account as determined by OCBC Bank. Upon being deemed an Eligible Customer, the Reward will be credited **within 3 months**.

3.3 Each Eligible Customer who participates in this Promotion is only entitled to receive one Reward under this Promotion throughout the entire Promotion Period.

### 4. General

4.1 The eligibility of any Eligible Customer to receive the Reward shall be determined at the absolute discretion of OCBC Bank.

4.2 OCBC Bank reserves the right at its absolute discretion to terminate the Promotion or vary, delete or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any cardholder and the dates of the Promotion.

4.3 OCBC Bank will not be responsible or held liable for any loss to or expenses that any person incurs in connection with the Promotion, including any error in computation, any breakdown or malfunction in any computer system or equipment.

4.4 The Reward is not transferrable or exchangeable for other items. OCBC Bank reserves the right to replace the Reward with any item of similar value.

4.5 OCBC Bank shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspects of Promotion and/or any product/service relating to the Promotion (including without limitation, the Reward). Notwithstanding anything herein, OCBC Bank shall not at any time be responsible or held liable for any defects or malfunction in any reward, and/or for any loss, injury, damage or harm suffered or incurred by or in connection with the use of the Promotion and/or any product/service relating to the Promotion (including without limitation, the Reward) by any person.

4.6 OCBC Bank's decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.

4.7 OCBC Bank shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.

4.8 These terms and conditions shall be governed by the laws of Singapore and the participants in this Promotion irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a participant of this Promotion shall have no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these terms and conditions.
