

Terms & Conditions Governing the OCBC Digital Home Loans and UNIQGIFT e-Voucher Promotion (the "Promotion")

Promotion Period

1. The promotion period shall run from 1 April 2020 to 31 May 2020 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") at its absolute discretion (the "Promotion Period").

Eligibility

- 2. You will qualify for the Promotion ("Eligible Customer") if you have successfully signed up for an OCBC Digital Home Loan (the "Loan") during the Promotion Period, subject to the following criteria:
 - The Loan must be applied for digitally through OCBC's online platform at < https://www.ocbc.com/personal-banking/loans/refinancing-home-loan.page, https://www.ocbc.com/personal-banking/one-advisor/
 - ii. The Loan amount must be a minimum of \$\$300,000.
 - iii. The Loan must be approved and accepted by 31 May 2020.

Promotion Mechanics

 Eligible Customers will be entitled to receive a UNIQGIFT voucher (the "Gift") during the Promotion Period, in accordance with the following:

Loan Amount	Gift
S\$300,000 to S\$1,000,000	S\$200 UNIQGIFT e-Voucher
Above S\$1,000,000	S\$300 UNIQGIFT e-Voucher

- 4. In accordance with regulations for property purchase, the e-Voucher value, S\$200 or S\$300 (depending on your loan size) will be deducted from the property purchase price to compute the adjusted purchase price and eligible loan amount.
- 5. OCBC will send Eligible Customers an SMS containing the e-Voucher link and PIN code to unlock the Gift.
- 6. The Gift can be used at any of the participating merchants listed at https://uniqgiftvoucher.com/merchants>, for multiple transactions in any denominations of S\$1.00, until the voucher value runs out or the voucher has expired.
- 7. OCBC reserves the right to substitute or replace the Gift with any item of similar value at its sole discretion without notice to any person.
- 8. The Gift is strictly not refundable and cannot be replaced if lost, damaged or expired.
- 9. The Gift is not exchangeable for cash, gift vouchers, gift cards, loyalty redemption programme points, and/or other goods and services.

If any Eligible Customer is subsequently discovered to be ineligible to participate in the Promotion or to receive the Gift (which eligibility shall be determined at the discretion of OCBC Bank), OCBC Bank reserves the right to (i) forfeit or withdraw the Gift at any time; or (ii) (where the Gift has been redeemed) claw-back the Gift or request the relevant customer to repay to or compensate OCBC Bank the value of the Gift at any time, and OCBC Bank shall have the right to debit the value of the Gift plus any goods and services tax or such other amount as it deems fit from the account(s) of the customer. No person shall be entitled to any payment or compensation from OCBC Bank should any Gift be forfeited or withdrawn, if any Gift is reclaimed by OCBC Bank, or if a customer is asked to repay to or compensate OCBC Bank the value of the Gift for whatsoever reasons.
