TERMS AND CONDITIONS GOVERNING NEW-TO-EASICREDIT BALANCE TRANSFER EXCLUSIVE ONLINE CAMPAIGN

- 1. The **Balance Transfer exclusive online campaign** on EasiCredit Offer ("Promotion") is open only to those who ("Eligible Account Holder"):
 - (a) have opened a new EasiCredit account with Overseas-Chinese Banking Corporation Limited ("OCBC");
 - (b) have an annual income of S\$30,000 and above;
 - (c) have received an SMS from OCBC inviting them to participate in this Promotion; and
