

**Terms & Conditions Governing the SeniorCare Event June 2026
(Exclusive to OCBC Ang Mo Kio Branch only)**

Promotion Period

1. The OCBC Ang Mo Kio SeniorCare Event (the “**Promotion**”) will take place on 21 June 2026 from 11:00 to 15:00 or such other periods(s) as may be determined and notified by Oversea-Chinese Banking Corporation Limited (“OCBC Bank”) at its absolute discretion (the “**Promotion Period**”).

Eligibility

2. You will qualify for the Promotion (“**Eligible Customer**”) if you fulfil any of these requirements during the SeniorCare Event located at OCBC Ang Mo Kio Branch, during the Promotion Period:
 - i. present your OCBC credit or debit card, or your OCBC app at the Complimentary food item booth
 - ii. scan and pay using any banking apps at the OCBC Mama Shop booth
 - iii. complete a Financial Needs Analysis (FNA)

Promotion Mechanics

3. An Eligible Customer who meets the conditions specified herein (“**Qualifying Customers**”) will be entitled to make one (1) purchase from OCBC Mama Shop (the “**Promotional Gift**”).
4. The Promotion is limited to Qualifying Customers who meet the conditions set out in these terms and conditions during the Promotion Period, and strictly while stocks last.
5. Qualifying Customers are entitled to receive a maximum of one (1) Promotional Gift per customer under this Promotion.
6. The Promotional Gift must be redeemed by Qualifying Customers at OCBC Ang Mo Kio Branch during the Promotional Period. Promotional Gifts which are not redeemed by the end of Promotional Period will be deemed to be forfeited.
7. The Promotional Gift is strictly not refundable and cannot be replaced if lost, damaged, expired or forfeited.
8. The Promotional Gift is strictly not exchangeable for cash.
