

**Great Eastern OCBC Affinity LifeSecure Promotion (“Promotion”) Terms & Conditions**

1. This Promotion is open to OCBC Affinity Members who purchase LifeSecure policy and/or rider (“Policyholder”) with a minimum annual premium of S\$800 (“Annual Qualifying Premium”). Annual Qualifying Premium refers to total combined premiums, inclusive of loadings (if applicable).
2. Promotion is valid for new LifeSecure policy and/or rider registered in Singapore between 1 August 2016 to 31 October 2016 and issued by 30 November 2016 (the “Promotion Period”).
