

Terms and Conditions of the Mighty Savers® 10th Anniversary Sign-up Promotion

Eligibility Criteria

- 1. To be eligible for the Mighty Savers[®] 10th Anniversary Sign-up Promotion ("Promotion"), you have to fulfil the following criteria:
