

Terms and conditions governing OCBC - Caltex Scratch & Win Promotion (1 July 2018 – 31 August 2018)

"You" refers to the customer.

About the Promotion & Eligibility

- The OCBC Caltex Scratch & Win Promotion 2018 (the "Promotion") runs from 1 July 2018
 Singapore Time (SGT) 00:00 till 31 August 2018 SGT 23:59 (both dates inclusive) or such other
 date(s) as may be determined by OCBC Bank in its sole and absolute discretion from time to time
 without prior notice in whatever mode of communication as OCBC Bank deems fit ("Promotion
 Period").
- 2. To take part in the Promotion, you need to be an Eligible Cardmember (as defined in Clause 3 below) and charge a relevant Qualifying Spend as outlined in Clause 4 below in a single transaction to your OCBC Credit or Debit Card at any Caltex service stations in Singapore during the Promotion Period ("Qualifying Transactions").
- 3. "Eligible Cardmembers" refers to someone who meets all of the following criteria:
 - a. You are an existing holder of an OCBC Credit or Debit Card (Corporate Credit Cards, Business Credit Cards and Private Label Cards and non-Singapore issued Cards are not eligible); and
 - b. Your OCBC Credit/Debit Card account(s) are in good standing with OCBC during the Promotion Period and the subsequent 6 months after expiry of the Promotion Period.

Qualifying Spend

4. Eligible Cardmembers will receive a maximum of one (1) OCBC Caltex Scratch & Win Card ("Scratch Card") upon meeting the relevant Qualifying Spend as outlined in Table 1 below, and the conditions set out in Clause 2 above and these terms and conditions.

- 5. Qualifying Transactions refers to Qualifying Spend in a single transaction on fuel at any Caltex service station in Singapore during the Promotion Period.
- 6. Scratch Cards are accorded to Eligible Cardmembers on while stocks last basis.

7. Eligible Cardmembers are entitled to a maximum of one (1) Scratch Card only per Qualifying Transaction.

- 8. Eligible Cardmembers should present the original Scratch Card at Caltex Service Stations to redeem for the gift or vouchers stated on the Scratch Card ("Prizes").
- 9. All Prizes are valid for redemption at any participating Caltex Service Stations before 15 September 2018, unless otherwise stipulated.
- 10. The Prizes are non-transferrable, non-assignable, non-exchangeable, and not saleable for cash, credits or other items other than the stipulated item on the Scratch Card.
- 11. Eligible Cardmembers who receive Prizes to offset their purchases are required to make the balance payment with their OCBC Cards.

General
