

Terms and Conditions Governing OCBC-Senoko Energy Open Electricity Market (Jurong) Promotion (the "Promotion")

Promotion Period

1. The Promotion shall run from 1 April 2018 to 31 August 2018, both dates inclusive ("Promotion Period").

Eligibility

2. You are eligible to take part in the Promotion ("Eligible Cardmembers") if:
 - (a) You are an existing OCBC Consumer Credit Cardholder and/or Debit Cardholder (the "OCBC Card") with a registered residential address with postal code starting 60, 61, 62, 63 or 64 who signed up for an electricity price plan with Senoko Energy by 30 June 2018;
 - (b) Your OCBC Card account(s) are in good standing with OCBC during the Promotion Period;
 - (c) You are among the first 5,000 to charge an electricity bill from Senoko Energy via recurring payment to your OCBC Card during the Promotion Period, of which the first recurring electricity bill must be charged to the OCBC Card by 31 August 2018.

For the avoidance of doubt, if your first electricity bill from Senoko Energy is charged via recurring payment to your OCBC Card after 31 August 2018, you will not qualify for the Promotion.

Promotion

3. During the Promotion Period, each Eligible Cardmember will receive a one-time S\$30 cashback when they charge their electricity bill from Senoko Energy via recurring payment to their OCBC Card.
4. The S\$30 cashback will be credited to your OCBC Card account by the end of the subsequent month following the first recurring charge.
5. For the avoidance of doubt, the maximum amount of cashback that one Eligible Cardmember (for both their Principal and all supplementary card together) can earn is S\$30.
6. The following cards are not eligible for the Promotion: OCBC Private Label Cards, OCBC Corporate Cards, BOS Voyage Corporate Cards and all OCBC Business Debit Cards.
7. OCBC reserves the right to claw back the rebate if you terminate the recurring payment on a OCBC Credit or Debit card within 6 months from the first recurring charge.

8. Only recurring transactions from Senoko Energy (“Eligible Transactions”) would qualify for the Promotion. For the avoidance of doubt, the following transactions **would not qualify** as Eligible Transactions:

Transactions made via NETS, Cash on Instalment, Instalment Payment Plan, Internet Banking, AXS, SAM, Mobile Applications, Online, Mail or Telephone Order to Senoko Energy would not qualify for cashback.

In the event of any ambiguity, OCBC retains the right to determine whether a particular transaction qualifies as an Eligible Transaction

General

9. OCBC has the right to end or withdraw the Promotion without giving you notice.
10. If there is any difference between these terms and conditions and any brochure, marketing or promotional material relating to this Promotion, these terms and conditions will prevail
11. OCBC has the absolute discretion to amend, vary or change these terms and conditions without your consent or providing any notice to you. OCBC’s decision on all matters relating to this Promotion will be final and binding on all participants.
12. These terms and conditions shall be governed by the laws of Singapore and the participants in this Promotion irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
