

## Terms and Conditions Governing the OCBC Visa Cards "Free Rides for Bus and MRT" Promotion

The following terms and conditions shall apply to the OCBC Visa Cards "Free Rides for Bus and MRT" Promotion (the "Promotion").

## 1. Eligibility

- 1.1 The "Promotion Period" starts on 6 June 2019 and ends on 31 July 2019, both dates inclusive.
- 1.2 "Eligible Customer" means any OCBC Cardmember who holds any of the following OCBC Visa credit or debit cards ("Eligible Cards"):

  - OCBC Premier Private Client VOYAGE Card
  - OCBC Premier VOYAGE Card
  - OCBC Robinsons Group Credit Card

  - OCBC VOYAGE Card
  - OCBC YES! Debit Card

## 2. Promotion Mechanics

- 2.1 To qualify for "Free Rides for Bus and MRT", the Eligible Customer shall, within the Promotion Period:
  - 2.2.1 Register for the Promotion at www.ocbc.com/transitvisa;
  - 2.2.2 Submit his or her Name per NRIC, Date of Birth and Mobile Number on an electronic registration form provided;
  - 2.2.3 Only the first 30,000 customers who register will qualify ("Qualified Customer") for the Promotion; and



- 2.2.4 The Qualified Customer needs to use his or her Eligible Card(s) to make payment for Bus or MRT fares ("Qualifying Spend"), either by paying directly with the contactless OCBC Visa credit or debit card, or through mobile payment with the OCBC Visa credit or debit card.
- 2.4 "Qualifying Spend" refers to all transactions recorded as 'Bus/MRT' under the Merchant Category Code (MCC) 4111, that is posted to his or Eligible Card(s) within the Promotion Period. OCBC Bank has the absolute discretion to determine whether a transaction is considered a Qualifying Spend or not.
- 2.5 OCBC Bank will award a S\$5 rebate to the Qualified Customer, provided that he or she accumulates at least S\$30 of Bus/MRT Qualifying Spend within the Promotion Period. The rebate will be credited to an Eligible Card of our choice. The rebate will be credited by 31 August 2019.
- 2.6 OCBC Bank reserves the right to disqualify any person from receiving the rebate and in event the rebate has already been awarded, to reclaim or withdraw the rebate from such person via various means, including but not limited to, debiting the value of the rebate from such person's card account. OCBC Bank reserves the right to correct any errors in its award of any rebate to any person at any time without notice. No person shall be entitled to any payment or compensation from OCBC Bank should any person be disqualified from receiving any rebate or should the rebate be forfeited, reclaimed or withdrawn.

## 3. General

- 3.1 OCBC Bank reserves the right to terminate this Promotion or vary, add or delete any of these terms and conditions without notice, including without limitation, the eligibility of any eligible customer and the dates of this Promotion.
- 3.2 OCBC Bank's decision on all matters relating to this Promotion will be final and binding on all participants. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.
- 3.3 These terms and conditions shall be governed by laws of Singapore and the participants in the Promotion irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
