

Terms & Conditions of “Stand a chance to win a Dyson V11™ Absolute cord-free vacuum cleaner with every payment using OCBC Pay Anyone™” (“Promotion”)

ELIGIBILITY:

1. This Promotion is open to all existing AXS customers, who make Qualifying Transaction (as defined in Clause 6) on Participating Channel (as defined in Clause 4) (“Eligible Customer”).
2. Staff of OCBC Bank (“OCBC”) involved in organising, promoting or conducting this Promotion, and staff of AXS Pte Ltd (“AXS”) and their spouses (if applicable) are not eligible to participate in the Promotion.
3. AXS may from time to time in its absolute discretion decide on the eligibility for participation in the Promotion.

PARTICIPATING CHANNEL:

4. Only OCBC Pay Anyone™ payment performed on AXS m-Station will qualify for the Promotion (“Participating Channel”).

PROMOTION PERIOD:

5. The Promotion shall commence from 1 October 2019 to 31 January 2020, both dates inclusive (“Promotion Period”).

QUALIFYING TRANSACTION AND CHANCE ALLOCATION:

6. Eligible Customers must successfully perform a transaction, regardless of amount, using OCBC Pay Anyone™ as the payment mode on the Participating Channel during the Promotion Period to be eligible for the Promotion (“Qualifying Transaction”).

CONDUCT OF DRAW:
