

Terms and conditions governing the Million LinkPoints Lucky Draw Promotion (the "Promotion") ("Draw")

"You" refers to the customer.

"We/ us" refers to OCBC.

Promotion

- The Promotion runs between 6 April 2017 Singapore Time (SGT) 00:01 till 3 May 2017 SGT 23:59 (both dates inclusive) or such other date(s) as may be determined and notified by OCBC Bank in its sole and absolute discretion from time to time without prior notice in whatever mode of communication as OCBC Bank deems fit. ("Promotion Period").
- 2. To qualify for the Draw, you must charge a minimum of S\$5 to your NTUC/OCBC Plus! Visa Credit/Debit Card ("Plus! Visa Card") during the Promotion Period.

Eligibility

- 3. You are eligible to participate in the Draw ("Eligible Cardmembers") if:
 - a. You are an existing NTUC/OCBC Plus! Visa Credit/Debit Cardmember during the Promotion Period;
 - b. Your NTUC/OCBC Plus! Visa Card account is valid and in good standing;
 - c. Your NTUC/OCBC Plus! Visa Card is issued in Singapore; and
 - d. You have charged at least \$\$5 at FairPrice Stores to your NTUC/OCBC Plus! Visa Card (either in a single transaction or over multiple transactions) (the "Qualifying Transaction").
- 4. For the purposes of these terms and conditions, 'FairPrice stores' means FairPrice Hypermarts, FairPrice Finest, FairPrice Supermarkets, FairPrice Online and Warehouse Club. 'FairPrice stores' excludes FairPrice Xpress and Cheers stores at Esso (refers to "ExxonMobil Asia Pacific Pte Ltd") service stations.
- 5. Qualifying Transactions performed on a Supplementary credit card will be aggregated with the Principal Plus! Visa Credit Cardmember.
- 6. 1 chance will be accumulated for every S\$5 Qualifying Transaction performed during the Promotion Period.
- 7. Chances awarded are based on the amount charged (in Singapore Dollars), rounded down to the nearest dollar. Example:

Spend Scenario	Amount Rounded To	No. of Chances
Charge S\$32.30 on Groceries	\$32	6
Charge S\$90.30 on Groceries	\$90	18

- 8. OCBC Bank's decision on the number of chances you receive will be final and conclusive.
- 9. Chances allocated to Eligible Cardmembers are non-assignable or transferrable.



- 10. You are not eligible to participate in the Draw if
 - a. Your NTUC/OCBC Plus! Visa Card is suspended, cancelled or terminated by us for any reason before or during the Draw, even if your other OCBC credit or debit cards may not have been suspended, cancelled or terminated; or
 - b. You are an employee of Oversea-Chinese Banking Corporation Limited or VISA Worldwide Pte. Limited, or its subsidiaries, their immediate family members, employees of any partners, sponsors and agencies (including, without limitation, any external auditor(s) and advertising agencies) who are directly involved in organising or the conduct of the Draw as determined by OCBC Bank in its sole discretion.

Prizes

How We Will Determine Qualifying Transactions

- 13. Spend with these NTUC/OCBC Plus! Visa Card transactions qualify:
 - a. Only transactions made at FairPrice Stores.
 - b. Such Qualifying Transactions are made on VISA payment platform; and
 - c. Such Qualifying Transactions are posted to the relevant OCBC Visa Card Account(s) between 6 April 2017 Singapore Time (SGT) 00:01 till 3 May 2017 SGT 23:59 (both dates inclusive)
- 14. We will decide on the type of transactions which qualify under this promotion.
- 15. OCBC Bank reserves the right to withdraw, cancel or invalidate the Draw chance(s) earned by any Eligible Cardmember without liability in any case of dispute, refunds, suspension, cancellation, termination of the Card account within six (6) months from 6 April 2017. OCBC Bank reserves the right to clawback amounts equivalent to any Prize that may be awarded to any Eligible Cardmember in any case of such dispute, refunds, or suspension, cancellation, termination of the Card account.

Draw

- 17. Winners will be picked at random by OCBC Bank (by manual or computerized means as OCBC Bank may determine) in the presence of its' auditors on 5 July 2017. OCBC Bank

We will contact the winners through telephone at their telephone number registered with us on or about 6th July 2017 for their consent to disclose or publish their information in TODAY or such other newspaper (s). Should the winner be uncontactable or does not provide us with his/her consent for his/her information to be published in the relevant newspaper(s), OCBC reserves the right and has the absolute discretion to award the Prize to the reserve winner drawn by us. The winners of the Draw will then be announced on 17 July 2017 in TODAY or such other newspaper(s) determined by OCBC.
- 19. If for any reason, the winner is unable to satisfy any or all of the Prize terms and conditions, he/she will lose his/her entitlement to the Prize.

General
