## Terms & Conditions Governing OCBC Plus! And NTUC Plus! Visa Card

## Redeem a \$\$20 Downtown East Voucher with a minimum spending of \$100

- 1) This Programme is valid from 19 November 2016 31 January 2017, both dates inclusive (Promotion Period).
- 2) Subject to these Terms and Conditions, a S\$20 Downtown East Voucher (the "Voucher") is given to a customer when he/she spends a minimum of S\$100 ("Spend Amount") on the same day at Downtown East with his/her OCBC Plus! and NTUC Plus! Visa Credit/Debit Card within the Promotion Period, limited to one redemption per day. For the avoidance of doubt:
  - Transactions incurred by a OCBC Plus! and NTUC Plus! Visa Credit/Debit Cardmember are entitled to the promotion.
  - If a customer wishes to accumulate his spending from NTUC FairPrice, the following additional conditions will apply:
    - (a) A customer needs to spend at least \$\$20 at NTUC FairPrice (the "Minimum NTUC Spend"; and
    - (b) Assuming that the Minimum NTUC Spend is met, all spends incurred by customers at NTUC FairPrice will be halved when used to attain the total Spend Amount. For instance, if a customer spends S\$100 at NTUC FairPrice, only half of that S\$100 spend (i.e. S\$50) will be used to attain the total Spend Amount. In this example, it would mean that if the customer wishes to get a Voucher, he/she needs to spend either S\$200 at NTUC FairPrice or S\$100 at NTUC FairPrice and another S\$50 at other participating tenants at Downtown East provided always that customers can only combine a maximum of 3 receipts for the purpose of attaining the total Spend Amount.
  - For Cardmember who holds both OCBC Plus! and NTUC Plus! Visa Credit/Debit Card, the
    amount spend on both cards will not be combined. Cardmembers can only combine a
    maximum of 3 receipts for the purposes of attaining the Spend Amount. There are only
    1,000 pieces of Vouchers to be redeemed under this Programme. Redemption of the
    voucher is on a first come first serve basis and is limited to OCBC Plus! and NTUC Plus! Visa
    Credit/Debit Cardmembers only.
  - At the point of redemption, the relevant customer's OCBC Plus! and NTUC Plus! Visa Credit/Debit Card together with his/her NRIC, E-Pass or S-Pass or work permit and receipt(s) (evidencing the Spend Amount and which must contain the last 4 digit of the customer's OCBC Plus! and NTUC Plus! Visa Credit/Debit Card number) must be presented for verification.
  - Only Visa transactions are eligible. The following types of transactions will <u>not</u> be considered
    as eligible towards attaining the Spend Amount: purchase of gift vouchers, Big
    Sweep/4D/TOTO tickets, cigarettes, Cash/NETS transactions, AXS transactions, SAM
    transactions and ATM cash withdrawals.
  - Receipts from the Temporary Atrium Fairs/Roadshows, Aranda Country Club, Wild Wild Wet, D'Resort are not valid. Management reserves the right to reject any receipts which are deemed not valid for the promotion.
  - Vouchers are non-exchangeable for cash or any other substitutes

3) OCBC Plus! and NTUC Plus! Visa Credit/Debit Cardmembers may redeem the Voucher at the following Customer Service Centre by presenting his OCBC Plus! and NTUC Plus! Visa Credit/Debit Card and all other required documents as stated in Clause 2 above:
