

**Terms and Conditions governing the National Day Esso 20% instant fuel discount promotion**

Subject to Clause 2 below, this Promotion (as defined below) is valid for holders of all OCBC (refers to Oversea-Chinese Banking Corporation Limited) Credit/Debit Cards except corporate cards and private label cards\* (“OCBC Cards”) from 8<sup>th</sup> August 2017 to 10<sup>th</sup> August 2017 (both dates inclusive) (the “Promotion Period”).

OCBC Cardmembers must also be an Esso Smiles member to be eligible to receive the 20% instant fuel savings per transaction (based on gross spend) charged to an OCBC Card at all FairPrice Xpress and Cheers stores in Esso (refers to ExxonMobil Asia Pacific Pte Ltd) service stations in Singapore only (“The Promotion”).
